Lane Pavements on the "Initiative"
Curbs and Gutters by "Petition"
Sidewalks by "Petition"

The Assessment Commissioner reported with respect to Schedule No. 326, Local Improvements, Street Pavements and Lane Pavements on the "Initiative" that sufficiently signed petitions had been received to defeat the following works:

Item 7	Pine Street	From 1st Ave. to 3rd Ave. From 3rd Ave. to 6th Ave.
Item 19	Lane South of 2nd Ave.	From Lorne Street to Scotia Street
Item 24	Lane South of 10th Ave. and the Lane West of Maple Street	From Maple Street to 10th Ave.

COUNCIL

The Council further considered the proposed Local Improvements approved by the Court of Revision receiving at this time the following recommendations from the City Engineer dated June 12th, 1964, endorsed by the Board of Administration under date of June 17th, 1964, in respect of subsequent procedure relative to the various projects:

1. The projects on the "Initiative Principle", except Items 7, 19 and 24, be proceeded with.
2. The projects "By petition" be proceeded with.
3. The other work connected with the projects, as shown on the Assessment Commissioner's reports on Courts of Revision Nos. 326 and 327 be approved, chargeable to Streets Fund, City's share of Local Improvement Section.
4. The City Engineer be authorized to call for tenders for permanent pavements and curbs and gutters.
5. The City Engineer be authorized to call for tenders for approximately one-half of the low-cost type surfacing

between gutters; the other one-half to be constructed by City forces for cost comparison purposes in this second year of the planned two-year development period.

THAT Item 2, Schedule No. 326, being a proposed Local Improvement, Street Pavement, on Cambie Street from Broadway to 16th Avenue be tabled pending an investigation by the officials concerned as to the equatibility of the front foot charges levied against abutting properties.

THAT all of the projects contained in Schedule No. 326, Local Improvements on the "Initiative" be proceed with, except Items 7, 19 and 24, being defeated items; Item 2, having been dealt with in the foregoing resolution, and Items No. 22 and 25.

THAT all of the projects contained in Schedule No. 327, Local Improvements by "Petition" be proceeded with in accordance with the recommendation of the City Engineer.

THAT in accordance with the recommendation of the City Engineer, the other work connected with the approved projects, as shown on Schedule Nos. 326 and 327, be approved chargeable to Streets Fund, City's share of local improvement section.

THAT in accordance with his recommendation the City Engineer be authorized to call for tenders for permanent pavements and curbs and gutters.

THAT in accordance with his recommendation, the City Engineer be authorized to call for tenders for approximately one-half of the low-cost type surfacing between gutters: the other one-half to be constructed by City forces for cost comparison purposes in this second year of the planned two-year development period.

THAT in respect of the sidewalk projects contained in Schedule No. 327 tenders be called for the entire sidewalk program.

THAT the City Engineer be authorized to call for tenders on this project; the bidders to be advised that the proposed work may not be proceeded with.
