This project is eligible for a contribution from the Kiwassa Neighbourhood Improvement Program (N.I.P.) as approved by Council on March 6, and May 15, 1979. Cost sharing of the recommended \$75 167 N.I.P. expenditure will conform to the standard N.I.P. utilities formula as follows:

CMHC has concurred with this allocation.

Capital Funds

Funds for the City's share of the cost of this project are available in already approved Capital budgets. Funds for the N.I.P. portion have already been allocated from the Kiwassa N.I.P. Accounts 891/8724 & 8728.

Recommendation

I recommend subject to the proceedings of the Court of Revision and subsequent approval of Council, that:

- (a) The Kiwassa area project 'on the Initiative' Schedule 457 be undertaken.
- (b) The project designated as 'other work' on Glen Drive from the lane south of Hastings to Georgia Street be undertaken."

The City Manager RECOMMENDS that the foregoing recommendation of the City Engineer be approved.
